- Platform: Office 365 hosted by GoDaddy
- Renewal: May 26, 2023 (except Al's) for \$33.48 / each / year
- Products: One 5-pack with 3 accounts. Six individual add-ons.
- Recommendations from GoDaddy:
  - Make local backups of 2 active accounts and move within the 5-pack product (delete/re-create process)
  - Make local backups of 3 non-active accounts
  - Turn on (purchase) "Email Archiving" for all accounts: \$4.99 / each / month
    - Provides automatic, compliant e-mail retention in a separate, searchable database
  - Cancel non-active accounts
