### Completed Work

- Continued Clean up and/or repaired equipment for auction on 8/29/2023
- Warbler Lane R.O.W clearing
- Warbler Lane culvert replacement with rip rap
- Warbler Lane culver removal
- Meetings with the Northern Pine Riders, the owners of Doc's and the Korner Store to relocate the ATV/Snowmobile trail from the South line of the Korner Store property to Doc's. This should solve a major issue with drainage that has been a problem for many years.

## Work in Process/Scheduled

 Meetings with Kiminski Paving, Gobel Excavating, Pine County, Korner Store Owner, and MN DOT to address an issue with ATV's at the intersection of Warbler and Lakeland Rd.
 MN DOT has the right of way and proposed a guard rail to guide the traffic. All have agreed to this proposal and the goal is to have it completed this fall.

#### Decisions and Comments

- There are approximately 15 miles of R.O.W clearing remaining. Most of the roads will need limited clearing. It is estimated to be under \$175,000
- Approval by road supervisor for quotes between meetings for continued R.O.W clearing in 2023
- Approve change order on Warbler Lane to to extend the project by 110' (approximately 2840 sq ft) to accommodate the ATV trail change at Doc's North entry on Warbler Lane Approve \$17,000
- Welcome to Windemere Township signs
